..... and whereas Vice-Chancellor, Dhaka University of Engineering & Technology, Gazipur has
agreed to the deputation/leave with average pay of the trainee for such higher study. Now the condition of the
above written bond is such that if the trainee must rejoin the University within a week after the completion of Ph. D
degree and after his/her returning and rejoining he/she will have to serve this University for the equal period of
his/her deputation/leave with average pay, and if he/she needs additional Leave without pay, he/she will have to
serve this University for the half of the period of the leave without pay approved by the syndicate. Otherwise,
he/she must pay all the money to the University, Pledged according to the condition of his/her service bond and
the authority of the University will confiscate the money accumulated in his/her General Provident Fund (GPF).
If he/she fulfils the mentioned conditions above written bond shall be void and no effect, otherwise the same shall
remain in full force and virtue.

Conditions stated bellow will also be applicable about my salary and service:

- 1. Any application by teachers seeking to be released while staying abroad for higher studies will not be entertained.**
- 2. If the concerned teachers want to be released before six (06) months after rejoining, they must have to pay out all the due pays and allowances from the date of approved leave for higher studies took effect and only then the release order may be issued.**
- 3. No dues (pays and allowances) will be paid before six (06) months after rejoining. After six (06) months arrears may be paid in two equal installments. The first installment will be paid after six (06) months of continuous active service while the second one will be provided after completion of one year active service.**
